



BANK LETTER OF GUARANTY FORMAT

Bidders using U.S. Bank accounts: To write a personal or business check for vehicle purchase(s) against funds drawn on and payable from your financial institution, a Letter of Guaranty, following the format outlined below, must be submitted on original bank letterhead with your application to approve your desired bid limit, verify account information and available funds. **You must pay for vehicle purchase(s) with a check written or a wire transfer against this account only.** No other checks will be accepted.

Bank Drafts are not accepted.

Bidders using non-U.S. Bank accounts: Letters must be written on Bank letterhead, using the 'Foreign Bidders Only' format below. You may also use another form of payment in **U.S. funds only.** *Personal or Business checks drawn on Canadian bank accounts cannot be accepted.

Please Note: Due to the enormous annual increase in Bidder Registration, and the influx of new bidders into the auction arena, it is imperative the Bank Letter formats are followed explicitly to prevent delays in the approval process.
