Dear Business Owner,

Welcome to Scottsdale! We have been made aware that you will be participating in the 2016 Barrett Jackson Auction on January $23^{rd} - 31^{st}$. We hope to make your application experience as simple as possible. Below is some information that will help you with this process.

All show participants selling merchandise or generating a sales tax liability are required to have a City of Scottsdale Transaction Privilege Sales and Use Tax License.

The annual license fee is \$50.00 if the application is received prior to the start date/event. If received after the start date please add a \$25 penalty.

Please complete the enclosed application and return it to us with the appropriate fees. Make your check(s) payable to: City of Scottsdale.

- If you live in another state, have a sales tax license from that state and do not plan to reside in Arizona, you may provide a copy of that license with the City of Scottsdale license application to meet the requirements below.
- Arizona State law requires that any individual/sole proprietor must present one of the following documents proving authorization to work in the United States:
 - An Arizona driver's license issued after 1996 or an Arizona non-operating identification license.
 - A driver's license issued by a state that verifies lawful presence in the U.S. (Licenses from IL, NM, WA, & UT do not meet the requirement) UT licenses issued after 1/1/10 are accepted.
 - A birth certificate issued in any state, territory or possession of the U.S.
 - A U.S. certificate of birth abroad.
 - A U.S. passport.
 - A foreign passport with a U.S. work visa. (For a complete list of acceptable documents please see document attached).
- If you are an individual/sole proprietor applying by mail, you must submit a certified copy of your birth certificate and a legible copy of your driver's license with the application or a copy of the sales tax license from the state your business is located (provided you do not plan to reside in Arizona.*)

If you have not filed and/or paid any previous sales tax returns, or fulfilled prior license requirements, you may not be able to participate in this event or any future events. Please call us if this is your situation so that we can work together to establish a suitable arrangement to bring your account current.

It is very important that you return your application PRIOR to the event. This will save you time, travel and inconvenience when you arrive in Scottsdale.

^{*}Please note that if you provided Right to Work documentation to the City of Scottsdale since October, 2008, you are not required to provide documentation until the documents you submitted have expired. If you provided your birth certificate or passport since October 2008 you will not be required to provide further documentation. LICENSING ELIGIBILITY CHECKLIST FOR SOLE PROPRIETORS

If you live in another state, have a sales tax license from that state and do not plan to reside in Arizona, you may provide a copy of that license with the City of Scottsdale license application to meet the eligibility requirements below.

Arizona State law requires that any individual/sole proprietor applying in person must present one of the following documents proving authorization to work in the United States:

Check the box next to the document indicating lawful presence.

An Arizona driver license issued after 1996 or an Arizona non-operating Identification license.
A driver license issued by a state that verifies lawful presence in the United States. (Driver
licenses CANNOT be accepted if issued by: HI, IL, NM, UT or WA) UT licenses issued
after 1/1/10 are accepted. HI licenses issued after 4/1/10 are accepted.
A birth certificate, a certified copy of your birth certificate or a delayed birth certificate
issued in any state, territory or possession of the United States. (See note below)
A United States certificate of birth abroad.
A United States passport.
A foreign passport with a United States visa.
An I-94 form with a photograph.
A United States citizenship and immigration services employment authorization document
or refugee travel document.
A United States certificate of naturalization.
A United States certificate of citizenship.
A tribal certificate of Indian blood.
A tribal or bureau of Indian affairs affidavit of birth.
A copy of a sales tax license from another state if the applicant does not plan to reside in
Arizona.

If you are an individual/sole proprietor applying by mail, you must submit a certified copy of your birth certificate and a legible copy of your driver's license with the application. Alternately, you may send a copy of your sales tax license from your home state (outside of Arizona) and a legible copy of your driver's license.

The licensing eligibility requirements do not apply to an individual, if <u>all</u> of the following apply:

- 1. The individual is a citizen of a foreign country or, if at the time of application, the individual resides in a foreign country.
- 2. The benefits that are related to the license do not require the individual to be present in the United States in order to receive those benefits.

Please Note: A Certified Copy of your Birth Certificate is a legal document obtained from your birth state for a nominal fee. We cannot accept a photocopy of your original birth certificate.
